

This is the last Will and Testament of me [redacted]  
of [redacted] Pork Butcher  
I revoke all testamentary instruments heretofore executed by me  
and I appoint my dear wife [redacted]

[redacted] Executors and Trustees of this my  
will I bequeath to my said wife [redacted] all the household  
furniture plate linen china glass books pictures jewels provisions  
and other household effects belonging to me at the time of my death  
and as to all the rest of my estate and effects both real and personal  
I devise and bequeath the same unto and to the use of the said  
[redacted] their heirs executors administrators  
and assigns Upon trust to sell call in and convert into money my  
real and residuary personal estate and upon further trust to invest  
the money arising from the sale calling in and conversion thereof  
in the names or name of the trustees or trustee for the time being  
of this my will as hereinafter authorized or directed and to pay  
the annual income of such investments to my said wife [redacted]  
during her life if she shall so long continue my widow and from and  
after her death or marriage again as to the capital and income of the  
same investments Upon trust for my children in equal shares the  
respective shares of such children to be absolutely vested in my  
death and if any of the children shall die in my lifetime leaving  
issue any of whom shall be living at my death such issue living at  
my death shall take equally amongst them if more than one the  
share which their respective parents would have taken if living  
at my death I direct and empower my trustees or trustee to invest  
my money requiring investment under or in consequence of any  
of the trusts or directions of this my will in any of the Public  
stocks or funds or Government securities of the United Kingdom  
or India or any other Colony or Dependency of the United Kingdom  
or upon freehold copyhold leasehold or chattel real securities  
in England or Wales or in or upon the stocks funds bonds  
debentures debenture stock mortgages or securities of any  
Corporation Company or public body municipal Commercial  
or otherwise in the United Kingdom or India or any other

Colony or Dependency of the United Kingdom with power from  
time to time to vary or transpose such investments. I declare  
that the trustees or trustee for the time being of this my will  
shall have a discretionary power to postpone for such period, as  
to them or her or him shall seem expedient the sale, calling in  
or conversion of any parts of my real or personal estate but the  
unsold real estate and the outstanding personal estate shall be  
subject to the trusts hereinbefore contained concerning the invest-  
ments aforesaid and the rents and yearly produce thereof shall  
be deemed annual income for the purposes of such trusts and the  
unsold real estate shall be deemed to be converted as from the  
time of my death and be transmissible as personal estate  
accordingly. I appoint my wife [REDACTED] during her widow-  
hood, and the said [REDACTED] guardians of any infant  
children of mine living at my decease. In witness whereof
